COMES NOW, Steven A. Harr, in his capacity as Examiner, and pursuant to the
procedure established by Judge Enslin in his order of October 10, 2003, files this Notice of
Billing Statements and for same would respectfully show unto the Court as follows:

BACKGROUND FACTS

1. On, April 14, 2003, Michael J. Quilling, Receiver for Advanced Financial
Services, Inc., filed a Complaint thereby initiating these proceedings and, in connection
therewith, sought the appointment of a Receiver. On April 15, 2003, the Court entered an
Agreed Order Appointing Receiver pursuant to which Bruce S. Kramer was appointed as
Receiver ("Receiver"), and he has continued to function in that capacity since that time.

2. On June 18, 2003. the Court entered its Order appointing Steven A. Harr,
Examiner. (Dkt. No. 90)

3. On July 23, 2003, the Honorable Ellen S. Carmody, United States Magistrate
Judge, conducted a Rule 16 Scheduling Conference in this matter. Among other issues
addressed was the request of the parties for authority for the Receiver to pay professionals in

this matter and for the Court's approval of same. The procedure recommend by the parties was set forth in the Status Report and approved by Magistrate Judge Carmody at the hearing. The procedure was incorporated in Magistrate Judge Carmody's Report and Recommendation of September 8, 2003. On October 10, 2003, the Court entered its order approving the procedure for the payment of professionals providing services to this estate. The procedure provides in part that the professionals will file a Notice of Billing Statements with the Court. Accordingly, this Notice of Billing Statements and attached billing statement is filed pursuant to the Court authorized procedures and will be served and posted on the Examiner's website for notice and objection. The statement is for the month of November 16, 2006 – December 14, 2006
